**Financial goals:** Whether you prioritize home ownership, retirement savings, travel, or education, aligning on major financial objectives prevents future conflict.


**Support expectations:** Clarifying whether alimony would be appropriate in various scenarios prevents feelings of entitlement or abandonment if separation occurs.
